# 發售價及配發結果公佈

## 概要

### 發售價及所得款項淨額

- 發售價已釐定為每股發售股份 0.315 港元(不包括 1.0% 經紀佣金、0.0027% 證監會交易徵費及 0.005% 聯交所交易費)。
- 按發售價每股發售股份 0.315 港元計算，經扣除本公司已付及應付與股份發售相關的包銷費用及佣金以及估計開支後，本公司將收到的股份發售所得款項淨額估計約為 20.7 百萬港元。本公司擬按本公佈下文「股份發售所得款項淨額」一節及招股章程「業務目標及未來計劃」一節所載用途使用該等所得款項淨額。

### 根據公開發售提出的申請

- 根據公開發售初步提呈發售的公開發售股份已獲極大幅超額認購。已接獲合共 9,250 份根據公開發售以白色及黃色申請表格及透過中央結算系統向香港結算發出電子認購指示提出的有效申請，認購合共 852,300,000 股公開發售股份，相當於根據公開發售初步可供認購的 20,000,000 股公開發售股份總數約 42.6 倍。
